#### I. Minutes

Karla Blackstock presented the financial report. The finance committee presented an investment strategy to help the Society's funds to grow at a maximum rate with minimal risk. They also presented the financial report and an update on the search for a new registry. Karla Blackstock shared the new chart of accounts that has been created with the help of Robert Morris Company. This significantly reduced the number of GLs that are not being used and directly connected expenses to income so that a detailed budget can be developed and followed. Brian Faris requested that an overview of the finances be provided each month with a quarterly report that is more detailed. LeAnn Winters would like the quarterly report to include P&L and information on investments. Brian Faris moved to accept the report. Doug Gillespie seconded the motion. Motion carried.
